# CHANGE OF BOARD CHAIRMAN FOR GREEN ARROW CAPITAL SGR: LUISA TODINI PASSES THE BATON TO NUNZIO LUCIANO

Former President of the Cassa Forense, Nunzio Luciano was also Chairman of the Advisory Board of the European Investment Fund (EIF) – AMUF and currently chairs the Strategic Committee of the *Green Arrow Infrastructure of the Future Fund* (GAIF).

Green Arrow Capital, with around  $\notin 2$  billion in assets, is currently raising its fourth Private Equity fund (*GAPEF IV Italian Champions*) dedicated to outstanding Italian SMEs, as well as its second Private Debt fund (*GAPDF II*), and the Infrastructure of the Future Fund (*GAIF*) which invests in renewable energy and digital infrastructures in Europe.

Nunzio Luciano has over twenty years of experience in Pension Funds and in the savings management sector. He was President of Cassa Forense for 7 years, a mandate during which he fronted important decisions on welfare measures and portfolio adjustments in sustainable investments and in real economy. Since 2021, he is Chairman of the BoD of EMAPI (Mutual Assistance Agency for Italian Professionals), and currently serves as Chairman of the Steering Committee of the *COIMA ESG City Impact Fund*, as well as Chairman of the Strategic Committee of the Green Arrow Infrastructure of the



Future Fund. Professor at the Luiss School of Legal Advisor, he covered, during the course of his career, a multitude of prestigious roles, amongst which Member of the Investment Committee of F2i SGR, Member of the BoD of Hope Sicaf Retail, Chairman of the Advisory Board of the European Investment Fund (EIF) – AMUF. He graduated in Law from the University of Naples "Federico II".
