management company in Luxembourg**

**Green Arrow Capital AIFM SARL will focus on Infrastructure and
Private Equity investment strategies.**

Milan, 16 April 2025 Milan – The Green Arrow Capital Group, one of the leading independent operators in the alternative and sustainable investments sector, continues its growth strategy with the establishment of Green Arrow Capital AIFM SARL in Luxembourg, reinforcing its international presence in the Alternative Investment Funds sector.

Green Arrow Capital AIFM SARL (GAC AIFM SARL), acting as a financial intermediary, will specialize in investment strategies focused on the Infrastructure and Private Equity sectors. The company aims to expand and strengthen its fundraising activities targeting international investors, while also establishing a dedicated platform for managing Luxembourg-regulated alternative funds.

Following the authorization granted by the Commission de Surveillance du Secteur Financier (CSSF), Green Arrow Capital AIFM SARL will operate as Alternative Investment Fund Manager (AIFM) and UCI Administrator (UCIA), for the management and central administration of Alternative Investment Funds (AIF), in accordance with the financial regulations of the Grand Duchy of Luxembourg. This will allow the Group to ensure structured, qualified, and internationally compliant management of alternative funds.

Wholly owned by Green Arrow Capital S.p.A., the new Luxembourg- based management company will be led by a Board of Managers and a Management Committee, with the aim of further consolidating Green Arrow Capital Group's international presence and pursuing its growth objectives through the launch of new Luxembourg AIFs, while leveraging the economies of scale that will be generated.

Green Arrow Capital is one of the leading Italian asset management platforms, focused on Alternative Investments with over €2 billion assets historically raised. To date, around 100 entities have invested in the Group's funds, almost 90% of which are represented by institutions (Banks, Sovereign Funds, Funds of Funds, Banking Foundations, Insurance Funds, Pension Funds, and Insurance Companies) and around 20% are of international origin.

Green Arrow Capital was founded in 2012 by Eugenio de Blasio, the Group's major shareholder as well as Chairman and CEO, together with co-founder Daniele Camponeschi (Group CIO) and partner Alessandro Di Michele (Group General Manager). The Partner and Deputy Chairman of SGR Francesco Maria Giovannini is actively involved in institutional relations. The Group operates in four different investment strategies - Energy & Digital Infrastructure, Private Equity, Private Credit and Real Estate - with dedicated and independent teams, and has currently in fundraising the fourth Private Equity fund (GAPEF IV Italian Champions), in support of Italian SMEs, as well as the Infrastructure of the Future Fund (GAIF), which invests in renewable energy and digital infrastructures in high-potential markets in Europe, and the Real Estate MiTo smart fund.
