**GREEN ARROW CAPITAL CARRIES OUT A NEW REVAMPING PROJECT IN SICILY  
TOGETHER WITH STERN ENERGY**

*The project involves a 10 MW photovoltaic plant owned by Green Arrow Capital (GAC) located in Partanna (Trapani), with the aim of ensuring a long-term operational continuity and efficiency, creating value for the local area.*

*Since entering GAC's portfolio, the plant has generated over 112GWh of renewable energy, equivalent to the energy consumption of more than 40.000 households and has helped avoid the emission of approximately 60.000 tonnes of CO<sub>2</sub>.*

Milan, 27 January 2026 - **Green Arrow Capital**, one of Italy's leading independent operators in the field of alternative investments, and **Stern Energy**, leading service company for utility-scale photovoltaic plants, announce the successful completion of a new major revamping intervention on a photovoltaic plant located in Partanna (Trapani). The intervention was defined following an in-depth technical assessment of the plant's condition and operational outlook, with the objective of ensuring long-term operational continuity and maximum energy efficiency, as well as creating value for the local territory.

The plant, owned by Green Arrow Capital and managed by Stern Energy since 2023, has an installed capacity of approximately 10 MW and an annual production of over 12 GWh. Since its entry into Green Arrow Capital's portfolio in 2018, the facility has generated more than 112 GWh of renewable energy, enough to power over 40,000 households, offsetting approximately 60.000 tonnes of CO<sub>2</sub>.

The revamping activities optimized the overall performance of the plant, bringing operational availability close to theoretical maximum efficiency levels (approximately 99%) and generating an increase in production of around 3.000 MWh per year. This operation is part of GAC's broader strategic pipeline aimed at improving the efficiency of operating plants, making them increasingly technologically advanced, enhancing renewable energy production capacity, reducing the intensity of maintenance activities, optimizing operational reliability and preserving long-term asset value.

The Partanna project specifically involved the 1MWp substations and included the replacement of the existing inverters with new centralized units supplied by Ingeteam, a leading company in the sector, as well as the replacement of the LV/MV transformers with new MV/LV transformers compatible with the supply voltage of the new inverters. The technical configuration of the intervention was designed to strengthen the plant's technological performance in line with sector evolution, with the aim of improving efficiency, reliability and maintainability levels. The project was carried out through meticulous planning and careful management of the operational phases, including the dismantling and disposal of equipment in compliance with regulations, installation of new components, cabling, commissioning and start-up.

Each substation was completed in approximately eight working days thanks to the strong synergy between the technical team and technology partners, requiring specialist expertise and precise coordination to ensure maximum efficiency and safety.
